- iii.) That while flying is in progress at your Club field, the SAMAA Rules, Regulations and Operations Manual requirements, which are on the website are observed at all times.**
- iv.) That all members who fly will be fully paid up Members of SAMAA.**
- v.) That any restrictions on the type and size of models flown at your field are followed.**
- vi.) That if an Event, be it a fly in, Airshow or Display be held at your field, permission will be applied for, and obtained by yourselves from SAMAA.**
- vii.) That before any CAA regulation is knowingly contravened, especially height, that your Club will apply for exemption, through SAMAA.**
- viii.) That if the environmental or development conditions at or around your Club change, in such a way that it could affect the suitability or safety of the field for model flying, SAMAA shall be informed of the changes immediately.**
- ix.) That if your Club is within 5 NM (9.26 km) or in the CTR or under the TMA of an Aerodrome you will comply and abide by the conditions set out in Procedure PR 19.**
- (x.) That if (ix) above applies to your Club, you will annually make contact, and will at all times maintain good relations with the Airport operator or tower Personnel.**
- xi.) Completion and return of this signed form F07, with authorised Resolution attached.**
- xii.) Other special conditions or limitations applicable to your field**
